RE: College Judiciary Committee Hearing

You have been charged by [REDACTED] with Sexual Assault, Harassment and Illegal Entry.

Based on the Title 9 Investigation Report the following charges are being brought

- 1) Sexual Assault (p131 of the Student Handbook) specifically sexual activity taking place without consent or ability to consent.
- 2) **Sexual Harassment (p 132-133 of the Student Handbook) changed 2 pm May 28, 2013**
- 3) Illegal Entry (p 128 of the Student Handbook)

These activities took place in April and May of 2011.

The College Judiciary Committee (CJC) will convene on **Thursday, May 30, at 9:00 a.m.**, to hear these charges. The hearing will be held in the President's Conference Room, 2nd Floor of Parrish Hall (West Wing).

Both sides have had the opportunity to bring witnesses and these statements have been reviewed by the Convener and Observer to determine whether or not the testimony is relevant and admissible. Also, these witnesses have been interviewed by our Title 9 investigator, Johanna Gallagher, to the best of her ability to reach them. You are responsible for making sure your witnesses are in attendance at the hearing.

Both sides have been informed that they may have a support person in attendance at the hearing. Each of you has identified the name of your supporter, if you have chosen to bring one. This person must be a current member of the Swarthmore community, is not able to speak at the hearing and is to be in the room with the participant.

CJC procedures are noted in your *Student Handbook (pages 148-155)*. I urge you to read them carefully and to consult with me if you have any questions about them.

All relevant materials submitted by either party and by the Title 9 investigator for the hearing may be reviewed in my office, starting at 9 am on Tuesday, May 28. Please remember that all CJC proceedings are confidential and should not be shared with the general public, except your family, therapist or and/or support person for the hearing.
